To establish ineffectiveness, a petitioner must show that "(1) counsel's performance was deficient; and (2) that the deficient performance prejudiced the defense so as to render the trial unfair and the result unreliable." Atkins v. State of Michigan, 692 N.W.2d 63, 67 (Wis. 2005). With respect to the prejudice prong, a petitioner must show that "there is a reasonable probability that, but for counsel's deficient performance, the result of the proceedings would have been different." Id. "A reasonable probability is a probability sufficient to undermine confidence in the outcome." Id. (quoting Strickland, 466 U.S. at 694). Accordingly, the petitioner must prove "that there is a reasonable probability that,
